Chief Lund also stated he is working on a list of junk vehicles around town. Blighted Structures: Chief Lund stated that he has gotten no response back from S Paulson, but he did sign certified mail for the letter. 6/6/2024 will be 30 days so a notice of hearing will be sent to S Paulson. Also, the trailer in Acks Trailer Park is owned by the County so not sure who to send the paperwork to so he will work on that. R Gruber approached the council and explained the owner of Northern View Trailer Park will be purchasing her trailer and fixing it up with new roof, electrical, plumbing, flooring, handicap ramp, etc. by a licensed contractor. Hoping to have it completed by the end of July 2024. M/S/C (TK/JL) Motion to approve 2nd reading of Ordinance 13.0107. Roll Call: Kramer, Linneman, Hanson, Wynn (Absent). Mayor let record show all in favor. Midco Agreement: Mayor Lanes explained Midco came out and inspected city hall which will be upgraded and the fire hall Midco stated that the mesh system would not work in the building, so they are working on a solution. Food Pantry/Museum will be updated as the system they have does not exist anymore. The contract will not be signed until the work is completed. Spring Clean-up: Mayor Lanes explained the dumpsters went very well and that they were here a little longer due to a miscommunication from Midco, but it worked out. The community seemed to use the dumpsters appropriately except for a few appliances that maybe couldn't get into the dumpster, but he had the placed inside the dumpster. Street Signs: Mayor Lanes explained he had reached out to a few places for replacement of the street signs but has not heard back from any of them with quotes yet. Tabled to next meeting. Xcel Energy: Bryan Sullivan approached the council regarding wanting to make a RTU site on A Avenue and that no facilities were needed. He explained they had purchased the land. Mayor Lanes explained that the property is zoned as Agricultural so would need to be rezoned. Attorney Warcup explained it would need to be changed to Industrial. A petition would need to be signed and then a notice placed in the newspaper for a hearing. Once the hearing is completed, they can proceed with a building permit for the project. The hearing is potentially set for June 4, 2024. State Bond for Auditor: M/S/C (JL/TH) Resolution 2024-06-03 Auditor Bond. A motion to set the City Auditor Bond at the amount of \$228,399.15, Resolution made and signed (JL/TH). Roll Call: Kramer, Linneman, Hanson, Wynn (Absent) Mayor let the record show all in favor. Red River Community Housing Development: Mayor explained this group is a grant funded non-profit organization that helps communities with redeveloping new affordable housing. Also, can help with infrastructure. City Benches: Auditor Klava explained the benches need to be sanded down and repainted as they are in bad shape. The council agreed and stated might be too expensive to have them sanded and repainted so
